Board Presentations

Wilson Presentation – Special Services

Allison Van Etten, Director of Specials Services, explained that two years ago the Wilson program was introduced to target dyslexia and other reading disorders. Mrs. Van Etten introduced the Special Ed teachers who have completed the Wilson certification and are now Wilson certified instructors, Holly Hachey, Emily Carvinho and Heather Harris and those teachers who are now going through the training Amanda Magliari, Jessica Palumbo, Shannon Cummings, Melissa Chimento and Tina Seraluca. These teachers shared videos of students during Wilson lessons, the positives of the program, how students respond to the program, and student data, which compared students' growth, and how it is influencing students' reading. A hardcopy of the data was shared with the Board. Mrs. Van Etten noted that five more teachers will be going through the training in the fall and by spring of 2017, we will have fourteen Wilson certified teachers.

Dr. Van Riley thanked the teachers for their hard work and sharing information on the program.

Frank Todisco shared his personal experience regarding the Wilson program. Mr. Todisco commented on how his daughter had difficulty in reading but being part of this program has helped improve her reading and she is now excited to read. Mr. Todisco thanked Holly Hachey for her work with his daughter in this program.

Unified Sports Essay Award Winner – Elizabeth Cavaliere

Greg Keith introduced Mystic Middle student, Elizabeth Cavaliere, the Unified Sports Essay Award winner. She was one of three students in the state to be recognized. Elizabeth Cavalier read her essay to the Board and community members.

Junior Project – SHS Students

Mark Friese introduced the Junior students who presented their Senior Project on a PowerPoint presentation. The students explained their project, which involves adding such items as floating benches, a sail for shade, artwork, and landscaping to the existing courtyard at the high school. The students explained the timeline, how they will fund the project and use of existing resources at the high school such as help from students in the Tech Ed and Art classes to finish the project.

Alexa Garvey commented on how the students did a nice job with the presentation and answered all her questions. Mallorie Geiger, Student Government Representative noted that she feels it will be a great addition to the courtyard and for the students. Frank Todisco commented that it was a great presentation and great idea.
