Moving Closer Toward Normal

We are very excited to move closer toward "normal" as four day in-person learning is now available to all DMS students. The COVID 19 pandemic has impacted all of us in many different ways and we ask for your continued patience and support as we make this transition.

Adjustments

Over the next few weeks, teachers and students will be adjusting to being in larger classes, and time will be needed to re-establish classroom routines, expectations, and peer relationships. Students will be adjusting to changes to their instructional spaces, reconnecting with peers they have not seen faceto-face in over a year, navigating new areas of the building for Specials, and adjusting to more students in the classrooms. Therefore, teachers will need to allocate time to review safety protocols, classroom procedures and expectations. Our teachers and staff will help students make connections and develop a sense of classroom community as the dynamic of the classroom changes.

Safety

To accommodate increased class sizes, we will now be operating with students being a minimum distance of 3 feet apart when they are in class or eating. Students and staff will continue to follow the safety protocols that were established at the start of the year. Mask wearing, social distancing, and frequent hand washing will continue to take place. Our maintenance department will continue to regularly sanitize various locations throughout the building, and a deep cleaning of the building will occur every Wednesday. Please continue to report any COVID-related symptoms that your child may have to our school nurse.

Learning at Home/Full Distance Learning

As a result of teachers having to focus their attention on the students in front of them, while also supporting our full distance learning students, we will not be able to accommodate requests to learn from home on any given day. Students who are registered for in-person learning will be expected to be in person on those four days. If your child is not feeling well, you should notify the office that he or she will be absent for that day and talk to the nurse about the requirements to return to school. Please note that we will only approve students to be temporary distance learning students **IF** you are being instructed to keep your child home due to school/state quarantining rules and/or due to COVID. We can not accommodate requests for temporary shifts to distance learning due to home schedules, appointments, or travel. Please recognize

that in many classrooms, teachers do not have any distance learning students and therefore are not set up to be live streaming every day unless given advanced notice.

Full distance learning students will continue to join their classroom's instruction for ELA and Math. Our full distance learners will continue to have the same classroom teachers and will receive both whole group and small group instruction. In addition, grade level staff may work collaboratively to support distance learning students for small group instruction to make sure they continue to receive the attention and instruction they need and deserve.

Dismissal

Lastly, teachers will assume that your child's dismissal plan will remain the same as it was when they were in school in the hybrid model. If you need to change your child's dismissal plan due to the returning to school for four days, it is important to complete the <u>Daily Dismissal Plan</u> and send it in with your child.

The SpeakUp Safety Tipline from Gaggle provides an easy way for students to share concerns about school safety and the well-being of fellow students.

Stonington Public Schools encourages students to report any concerns directly to an administrator, counselor, support staff, or trusted adult. Face-to-face interaction is always the best form of reporting to ensure we have all the necessary information to be able to act accordingly. If this is not feasible, then we encourage you to use the anonymous reporting feature described below.

Items you should report:

- Bullying (you experience or if you observe others being bullied either in person or online)
- If you or another student is in crisis, depressed, self-harming or thinking about suicide
- Any knowledge of a planned fight or disturbance of any kind
- Someone threatening or bringing a weapon to school
- Any issue that is of concern to you

With the warmer weather, your child can do some music activities outside, such as listening to nature's "orchestra!" Sit quietly for 1 minute and observe all of the sounds you hear. What sounds did you hear? (birds chirping, the wind, man-made sounds, water, leaves rustling, etc.) Encourage your child to recreate these sounds with body percussion, found or natural sounds (sticks, leaves, rocks, etc.) They could even make a "sound map" and draw out the area on a piece of paper and draw a symbol of what they heard in the approximate location. Scoliosis screenings for 5th Grade girls

The State of Connecticut mandates that school nurses conduct postural screenings for female students in grade 5. School nurses will be performing this screening during the months of April and May. You will be notified of the exact date in advance so that your child can dress accordingly.

The purpose of this program is to recognize the signs of spinal curvature at its earliest stages so that the need for treatment can be determined. Specifically, scoliosis is a sideways curvature of the spine. In its early years, it is painless and develops gradually, especially during the years of rapid adolescent growth. Kyphosis, sometimes called round back, is an exaggerated forward bend of the spine and is often confused with poor posture. Many cases of curvature of the spine are mild and require only ongoing observation by a doctor after the first diagnosis. Others get progressively more severe as the child grows and require active treatment. Early treatment can prevent the development of a severe deformity which can affect a person's appearance and health.

Each student will be screened individually by school nurses. The nurses will inspect the student's spine as he or she stands and then bends forward. The student's entire back from shoulders to hips need to be observed without covering. Girls should be observed wearing a two-piece bathing suit top or bra.

If further consultation is recommended, parents will be notified in writing of the findings and will be asked to seek further evaluation from their own physician.

If you have any questions, please contact your child's school nurse.

Allergy season:

As you know, allergy season is guickly approaching here in New England. Please be advised that many allergy symptoms are also consistent with COVID-19 symptoms. Please be sure to check with your child's doctor and manage symptoms accordingly.

Facts About the COVID-19 Vaccine ct.gov/covidvaccine



Who makes the vaccine?


Currently, two vaccines are authorized and recommended to prevent COVID-19. Pfizer-BioNTech and Moderna

Both vaccines went through a rigorous, transparent clinical trial and approval process and were found to be >94% effective



Medical experts agree that both vaccines are safe and effective at protecting you against COMD-19

Will the vaccine give me COVID-19?



The COVID-B vacone is an mRNA mRNA vacones give our cells instructions for making a harmlass protein found on the outside surface of the wrus that causes COVID-19. This "spike protein" trains our immune system to target the virus when it shows up.

Will the vaccine protect me from getting sick with COVID-19?

Yes. The vaccine can keep you safe by preparing your immune system to immediately recognize and fight the virus that causes COVID-19 before it can spread and cause damage.

When will I be protected?

You must receive 2 doses of the vaccine 3-4 weeks apart for maximum protection against COVID-19. Full protection occurs about 2 weeks after your second dose.

Does the COVID-19 vaccine change my DNA? NO. The COVID-19 mRNA vaccines cannot alter your DNA in any way.

What if I've already had COVID-19, do I still need to get vaccinated?

Yes. It is important to get vaccinated for longer and better protection.

According to the CDC, 'because there are severe health risks associated with COVID-19 and the fact that re-infection with COVID-19 is possible, the vaccine should be offered to you regardless of whether you already had COVID-19 intection."

Do I still need to wear a mask?

Yes. We will still need to protect our families, friends and communities from COVID-19 while people are getting vaccinated: Mask. Social Distance. Avoid Large Groups, Practice Good Hand Hygiene.

- School will continue to follow the State of CT Travel Advisory. Any changes will be announced and put into place.
- Board of Finance to review the budget. Waiting on date to be set for town meeting/ referendum. More to come in regard to this.
